The new OFFICERS for the 2020-2021 year were elected at the very first

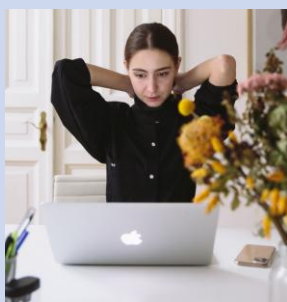
